SYLLABUS AND OVERVIEW OF COURSE

This class undertakes a look at the backstage workings of the theatrical adventure through experiencing the process: from actual construction of a set, to application of theatrical makeup, to investigating the processes of theatrical scenic and costume designers, and culminating in the actual design of a production.

1. As necessary, during the course of the semester, class time will be spent actually working on sets to be used in production: building, painting, etc. Please dress appropriately for these class sessions.
2. We will do an overview of theatre and theatrical design history.
3. We will investigate the process of the designer in conceptualizing and realizing ideas for the artistic demands of the script (i.e., 'the process').
4. We will read a play (wow!). We will analyze the text, discuss it in VISUAL terms, and present possible ideas for mounting the play in production.

6. (Here's where the fun really begins) - We will examine and discuss the process of the Scenic and Costume Designers. Following, each member of the class will select a play (limitations of choices to be discussed later) and you will DESIGN the show. Your design will include thumbnail sketches, perspective drawings, front and rear elevations, blueprints, and a full-scale model for the set; as well as a selection of full-color costume renderings with material swatches. Most drawings will be computer-generated._

Sound daunting? Relax (but not too much). It has been my experience that this class turns out to be a great deal of fun for almost all who participate. (And a near-death experience for those who slide by and think they will be able to do their entire design on the night before the final.) Note the word PARTICIPATE. Some of you are entering this adventure with previous experience in these areas - others are coming into it blind (or at least in need of prescription lenses). Neither talent nor experience is the key to success in this class. Anyone who tries his/her utmost, comes to class, DOES THE WORK (!) - makes an 'A'. I will ultimately learn from you as you learn from me.
