Student Learning Outcomes for the Course

- 1. Perform calculus operations on vector-valued function, including derivatives, integrals, curvature, displacement, velocity, acceleration and torsion.
- 2. Perform calculus operations on functions of several variables, including partial derivatives, directional derivatives, and multiple integrals.
- 3. Find extrema and tangent planes.
- 4. Solve problems using the Fundamental Theorem of Line Integrals, Green's Theorem, and Stokes' Theorem.
- 5. Apply the computational and conceptual principles of calculus to the solutions of real-world problems.

Student Requirements for Completion of the Course and Due Dates

Students should have 2 one inch, 3 hole binders. Homework is to be completed on paper and kept in a notebook. Chapter tests are taken in the classroom on paper. Maple assignments are completed on computer and submitted in the student folder. Final exams are in the classroom at the assigned date. Due dates are listed on the schedule. At the end of a chapter, a folder with homework and notes will be turned in for grading.
