Course Description: This course covers the knowledge, skills, and abilities essential to provide basic care to residents of long-term care facilities. Topics include resident's rights, communication, safety, observation, reporting, and assisting residents in maintaining basic comfort and safety. Emphasis is placed on effective interaction with members of the health care team. Students may have the opportunity to job shadow and participate in volunteer activities to prepare for clinical rotations.

Student Learning Outcomes: Upon successful completion of the course, the student will be learn to:

1. Discuss and observe basic care of residents in long term care facilities.
2. Communicate and interact effectively with residents and their families based on sensitivity to the psychosocial needs of residents.
3. Discuss and promote safety measures.
4. Demonstrate skills in observing and reporting.
5. Assist residents in attaining and maintaining maximum functional independence.
6. Protect, support, and promote the rights of residents.
7. Function effectively as a member of the health care team.
8. Demonstrate legal/ethical behavior and appropriate written and verbal communication skills using the terminology of the occupation and the business/industry.

Late work is not accepted! A zero will be given for any late/missing work. If a student is absent the day an assignment is due, he/she is expected to turn it in on the day of return. If the student is absent the day an assignment is given, he/she will have the total number of days absent to complete the assignment. There will be a minimum of 15 daily grades and 3 test/project grades per grading period. Failure to make at least a 70 for the grading period will result in automatic removal from this course.

Requirements for Job Shadowing/Volunteering/Clinical Training:

- Proof of completed Hepatitis B vaccination series, negative TB skin test, and other vaccines as **required by the facilities**
- Satisfactory criminal background check and drug screen
- Liability insurance
- Successful skill check-off/satisfactory attendance/coursework
- Heavy lifting

Confidentiality: All information gained in the nurse aide program relating to residents, families, health care providers, or any other private facility business is considered confidential information. Disclosure of any confidential information is cause for immediate dismissal from the CNA program.

Contact Hours: Basic resident care skills will be taught in the classroom and lab setting. After skills are mastered, students will apply these skills in the workplace or in virtual clinical experiences. Students are required to complete at least 60 classroom hours and 40 clinical hours. **Students who fail to meet the compulsory attendance requirements will NOT be eligible to take the nurse aide certification exam.** Make-up days in the clinical setting may be scheduled on weekends and/or evening hours at the discretion of the instructor. Failure to make up missed time may result in removal from the class and ineligibility to take the certification exam.

Professional Conduct and Dress Code: CNA students are expected to act in a professional manner at all times. If a student participates in any unethical, unprofessional, or disruptive behavior, the student may be removed from the clinical site and may be subject to dismissal from the program.

Behavior: This course is meant to prepare students for a job in the healthcare field; therefore, professional behavior is expected. Please adhere to the following rules while in this class or in the clinical setting.

- Cell phones and other electronic devices should be silenced and put away when entering the classroom. Chromebooks may be used at the teacher's discretion.
- No food should be consumed during class. Water bottles are permitted.
- Disrespectful comments and inappropriate language are not acceptable.
- Paper, class materials, books, and pencils/pens should be brought to class each day.
- Class time should be used wisely.
- Only use the equipment in the room if you have permission. If you break any equipment due to misuse, you will be required to pay for it.
- Be respectful of others.
- Pay attention. (No sleeping!)
- This course contains material about the human body/reproductive health/STDs, etc. Material will be presented in a professional manner, and students are expected to act appropriately. No crude/vulgar or offensive language will be tolerated.
- Please refer to the Texarkana College Student Handbook and the NBISD Student Code of Conduct for the full list of rules, policies, and procedures related to student conduct.
- Students must be punctual for all off-campus clinical experiences. After 15 minutes, a tardy is considered an absence. Clinical attendance is an integral part of the class.
- Food/drink may only be consumed during an authorized break in the clinical setting. No food/drink should be consumed in class.
- Cell phones and other electronic devices may NOT be used in the clinical setting.
- All equipment and supplies must be handled carefully. Students will be required to pay for equipment that is lost or broken while in their care.
- Infection control measures and proper body mechanics must be utilized at all times.
- Students will only perform the skills for which they have been trained.
- Honesty is vital. Any errors or mistakes will be reported to the instructor immediately.
- Sensitive topics are covered in this course. Students are expected to use proper anatomical terms and to approach these topics in a mature, professional, and respectful manner.
- If you must miss clinical due to an illness or other emergency, you must notify Mrs. Grider immediately. **Texting, emailing, or sending a message via a classmate is not acceptable.** Failure to follow these guidelines will result in a written reprimand for the first violation. The second violation constitutes grounds for **dismissal from the program.**

- A scrub suit will be required for each off-campus clinical. Only solid color scrubs will be permitted. **Scrubs must be CLEAN and IRONED and must fit appropriately.** Closed-toe shoes are required. Socks must be matching. A student I.D. badge must be worn at all times during any clinical training. Badges are provided by NBISD.
- Only small earrings are allowed during clinical training. (No other jewelry) Any additional body piercings (including tongue piercings) and/or gauges must be covered or removed and cannot be visible while in any clinical setting.
- Fingernails must be short and clean. **Artificial nails are inappropriate for clinical training.**
- Students must wear a watch with a second hand while performing vital signs. (No digital watches)
- Good personal hygiene must be maintained at all times by students enrolled in this program.
- Hair should be neat and clean. Hair must be secured away from the face.
