**Course Description:** Continuing Ceramics I: creating pottery forms by use of the slab, pinch, coil and throwing methods: firing and glazing.

**Student Learning Outcomes:**

1. Complete an art journal containing drawing assignments, photo section and research.
2. Complete a specific number of clay works using multiple construction methods.
3. Create an assemblage in mixed media.
4. Produce exhibit level works as final works.
5. Produce one work that must be a minimum of 16" high.

**Student Assessment**

Grades will come from your journal, lab work, projects, lab attendance, and any other special assignments such as critiques and art shows. Test will also be used.

90% - 100% = A

80% - 89% = B

70% - 79% = C

60% - 69% = D

0% - 59% = F

All late projects will result in the loss of a letter grade on that assignment. Each work will be graded on the quality and craftsmanship displayed.

Works not worked on in class will not be graded. The work must have instructor input.

Exhibit and critiques will be graded.
