**Course Description:** Students will learn drug dosages, classifications of drugs, side effects and disease processes that warrant the use of medications.

**Student Learning Outcomes:** Upon successful completion of the course, the student will be able to:

1. Identify and explain drug dosages, routes of administration, and dosage forms.
2. List the various types of drugs utilized in the treatment of disease.
3. Define various disease processes, patterns, and pathogenic organisms.
4. Identify and define a variety of drug classifications.
5. Distinguish the five pregnancy categories and how they affect drug classifications.
6. Explain drug nomenclature.
7. List and explain the rights of administration.
8. Identify abbreviations for common routes of administration and dosage formulations.
