Student Learning Outcomes For The Course

Upon successful completion of this course, students will:

1. Compute the values of trigonometric function for key angles in all quadrants of the unit circle measured in both degrees and radians.
2. Graph trigonometric functions and their transformations.
3. Prove trigonometric identities.
4. Solve trigonometric equations.
5. Solve right and oblique triangles.
6. Use the concepts of trigonometry to solve applications.

Student Requirements For Completion Of The Course And Due Dates

1. Homework assignments are to be completed using MyMathLab (MML). You will receive credit for assignments turned in on or before the due date. Due dates are listed on MyMathLab and in the Tentative Course Schedule. Any changes in due date will be posted on MyMathLab. At the end of the semester your lowest 3 homework grades will be dropped and will not count towards your homework average.
2. Tests – Some tests and assessments may be assigned for completion outside of regularly scheduled class meetings in the TC Testing Center located in the Palmer Library (details provided in the tentative course schedule). Check with the Testing Center for current hours of operation.

There will be a total of 6 chapter tests as follows:

Test 1: Chapter 1	Test 2: Chapters 2 & 7.1-7.3	Test 3: Chapter 3
Test 4: Chapter 4	Test 5: Chapter 5	Test 6: Chapter 6

There will also be a Core Curriculum Assessment that will count as a test grade.

3. Final Exam – There will be a multiple choice comprehensive final exam that will be administered in the classroom on the assigned date according to the campus-wide final exam schedule. You will need to bring your own scantron to the final exam. Practice final exams are available for purchase in the bookstore. The final exam may be used to replace your lowest chapter test score if your final exam score is higher.

Student Assessment

You have opportunity to earn points in the following 3 areas. Your final grade will be determined by the corresponding percentages.

Homework	20%
Chapter Tests/Core Curriculum Assessment	60%
Final Exam	20%

Final Grade = $0.20 \times \text{homework average} + 0.60 \times \text{chapter test/core curriculum average} + 0.20 \times \text{final exam}$

Absentee Policy

Texarkana College's absentee policy allows instructors to withdraw a student from a course due to excessive absences. If a student leaves and returns during class or leaves the class before the class is over, he/she **may** be considered absent. Three tardies may be counted as one absence. Experience demonstrates that regular attendance enhances academic success. As such, students are expected to attend each meeting of their registered courses.

A student should not stop attending a class without formally withdrawing from the course by the institutions published Last Day for Students to Drop. If a student stops attending class after the published Last Day for Students to Drop, the student may receive a grade of "F" in the class. The instructor will submit the last date of attendance for students receiving a grade of "F" or "W".

Withdrawal from a course(s) may affect a student's current or future financial aid eligibility. Students should consult the Financial Aid Office to learn both short and long term consequences of a withdrawal.

Excused Absences

An absence is defined as any time you are not in class. A student's absence due to school trips and/or school business will not be counted against a student's allowable number of absences. Military duty and absences for Holy Days (FBD LEGAL) are covered in a separate section of the catalog and the student handbook. These are the only excused absences that are considered by Texarkana College. Responsibility for work missed for any absence is placed on the student. Instructors are required to allow students to make up work missed if the absence is due to military duty* or religious holy days when students follow the correct notification procedures. Instructors are not required to allow students to make up work for absences due to other reasons.

Maximum Allowable Absences

The maximum allowable absences refers to the maximum number of unexcused absences a student is allowed before a student may be dropped from the course. After official registration for a three credit hour academic class that meets two days a week, the instructor may withdraw a student from the course if they exceed 4 absences. This means you may be dropped from the course for having 5 recorded absences.

Make-Up Policy

Students may make up missed tests if the absence is due to military duty or religious holy days when students notify the instructor prior to being absent. Students may also make up tests due to an emergency (documentation may be required). In the event of an emergency, the student must contact the instructor prior to the test. Faculty members are not obligated to provide opportunities for students to make-up

missed assignments and tests as a result of a student's absence from class. It is the student's responsibility to communicate with the instructor regarding absences and missed course work. The instructor has the final say whether or not a student will be allowed to make up the missed test. Make up tests may be a different form of the test. Any missed test will be recorded as a zero. Students may have the homework due date extended for excused absences (See excused absences above). You will not receive credit for homework assignments after the due date has passed. At the end of the semester your lowest 3 homework grades will be dropped and will not count towards your homework average.

Tutoring and Extra Help

Texarkana College also offers free tutoring to all students, including online students, in the Math Lab located on the second floor of the Library. In order to use the tutoring available in the Math Lab, simply bring your Student ID with you to the library, go upstairs to the area labeled Math Lab and use your ID to sign in (on the designated sign-in computer), then work on any math work at the computers or tables in the Math Lab area. Check with the Math Lab for current hours of operation.

Class Behavior

Each student must respect the learning environment of others, therefore, there will be a zero tolerance policy for any behavior that is disruptive to classroom learning. This includes ANY use of vulgar language or rude behavior toward instructor or any other student in the class. This also includes disruptive cell phone usage during class! Please be considerate of others who are trying to learn by using your cell phone appropriately during class time.

Course Correspondence:

Course correspondence will be through TC student email, REMIND, MyMathLab, or the email you provide when you sign up for MyMathLab. Grades and attendance will be posted on MyTC. It is the student's responsibility to check his/ her email, MyTC, and MyMathLab regularly for any information relating to the course.

Scholastic dishonesty, involving but not limited to cheating on a test, plagiarism, collusion, or falsification of records will make the student liable for disciplinary action after being investigated by the Dean of Students. Proven violations of this nature will result in the student being dropped from the class with an "F".
