## **Textbook/Supply Information**

## **Student Requirements for Completion of the Course and Due Dates**

**Homework:** Homework assignments are to be completed using MyMathLab (MML). You will receive full credit for assignments turned in by the due date @ 11:59pm. Assignments after the due date will be recorded as a zero. At the end of the semester your lowest 3 homework grades will be dropped and will not count towards your homework average.

**Tests** – All chapter tests will be taken online in the TC Testing Center located on the first floor of the Academic Commons(library) or a proctored setting(see **Proctors**), except chapters 12,13 test. That test may be taken at home. There will be a total of 4 chapter tests as follows:

Test 1: Chapters1, 2 Test 2: Chapter 3 Test 3: Chapter 11

Test 4: Chapters 12, 13 may be taken at home

\*I will replace your lowest test score with your final exam grade if it improves your final average.

**Final Exam**: A final exam will be administered. The final exam must be taken online in the TC testing center or your proctored setting any time the testing center is open. You may take it early if you are ready but the absolute deadline is the close the testing center on the last day of class.

All major tests, except for those listed, and the comprehensive final will be taken in the TC testing center or your proctored setting(if you live out of town and have arranged it with me).

\*NOTE: Calculators are allowed on all work unless otherwise instructed.

# Important Class Information READ THIS!!!!!

Homework assignments must be completed by the due date @ 11:59pm of each week they are assigned for credit. Assignments turned in after the due date will be recorded as a zero. Students have <u>unlimited</u> attempts to complete each assignment before each due date. Assignments are located under the "Homework" button on your MML dashboard. After 3 attempts, select "similar exercise" for a new question. You can keep doing this as long as you would like until the due date or the desired grade is achieved.

Chapter tests are password protected and will not be accessible unless the student is in the Testing Center except for those tests listed to be taken at home. You may take a chapter test as soon as you see it posted in MML. You do not have to wait until the due date to take your test. Tests are located under the "Quizzes & Tests" button on your MML dashboard. Reviews for each test can be also found on MML under the "Quizzes & Tests" button. Reviews are for practice only and don't affect your grade but are HIGHLY recommended.

\*All due dates are final so please don't ask for extra time. It is your responsibility to make sure your work is completed and tests are taken by the due date.

<sup>\*</sup>Students must abide by all Testing Center rules and regulations.

The links you will need to use for this course on your MML dashboard are "Course Home", "Homework", "Quizzes & Tests", "Important Info/Documents" and "Gradebook". All other items on MML are optional for you to use, but use all of it that you need to be successful.

<u>Calculators</u> will be allowed on any course work. All work on tests taken at the testing center will need to be shown on scratch paper numbered in appropriate sequence and legible and turned in with your test. Scratch paper and sometimes a graphing calculator are available in the testing center if needed, you just have to ask.

Correspondence from the instructor will be given through the student's Texarkana College email account. Please check your email regularly for updates and announcements. Announcements will also be posted on MML and sent to the email account you register with MyMathLab.

A student may be **dropped** from this course for any of the following reasons:

- (1) Missing 3 major tests
- (2) Missing **3** or more weeks of homework
- (3) Any breach of conduct (see Student Handbook)

Cheating is prohibited. Anyone caught cheating on an assignment or test will have earned an' F' for the semester OR you may be dropped from the course.

#### **Absentee Policy**

Texarkana College's absentee policy allows instructors to withdraw a student from a course due to excessive absences. If a student leaves and returns during class or leaves the class before the class is over, he/she **may** be considered absent. Three tardies constitute one absence.

Faculty members **are not** obligated to provide opportunities for students to make-up missed assignments and tests as a result of a student's absence from class. The institution is not required to take attendance with the exception of workforce/vocational areas, where certification requirements require taking attendance. However, experience demonstrates that regular attendance enhances academic success. As such, students are expected to attend each meeting of their registered courses.

A student should not stop attending a class without formally withdrawing from the course by the institutions published Last Day for Students to Drop. If a student stops attending class after the published Last Day for Students to Drop, the student **may** receive a grade of "F" in the class. The instructor will submit the last date of attendance for students receiving a grade of "F" or "W".

Withdrawal from a course(s) **may** affect a student's current or future financial aid eligibility. Students should consult the Financial Aid Office to learn both short and long term consequences of a withdrawal.

#### **Online/Hybrid Course Absences**

Absence in an **online course** is defined as the lack of an active post or submission within the course including discussion board posts, written assignments, and tests. This standard will be used to determine all absentee issues, including but not limited to, 12<sup>th</sup> Day Census Reports, last date of attendance, and involuntary withdrawal from a course due to absences. All online students must complete an Enrollment Verification activity within the first week of class (activity depends upon the professor); otherwise the professor **may** drop the student for not having attended. Students must complete at least one activity in their online class per week. Each week in which a student does not complete an activity will be counted as an absence.

If a student is taking a hybrid course, and it does not meet during the first week of class, the student must also complete an Enrollment Verification activity within the first week of class; otherwise the student **may** be dropped for not having attended.

## **Excused Absences**

A student's absence due to school trips and/or school business will not be counted against a student's allowable number of absences. Military duty and absences for Holy Days (FBD LEGAL) are covered in a separate section

of the catalog and the student handbook. These are the only excused absences that are considered by Texarkana College. Responsibility for work missed for any absence is placed on the student. Instructors are required to allow students to make up work missed if the absence is due to military duty\* or religious holy days when students follow the correct notification procedures. Instructors are not required to allow students to make up work for absences due to other reasons.

\*Students interested in Health Occupations should check with the division chair prior to entering the program.

#### **Maximum Allowable Absences**

After official registration, the following number of unexcused absences will be the maximum allowable before a student **may** be dropped from the class. For a three hour Online Academic class, an instructor may withdraw a student from a course if they exceed 2 absences.

## **Make-up Policy**

There will be no make-up exams for major tests. Any test missed will be recorded as a zero. Any student missing 3 major tests may be dropped from the course. Students may have the homework due date extended for excused absences (See excused absences above).

## **Academic Integrity Statement**

Scholastic dishonesty, involving but not limited to cheating on a test, plagiarism, collusion, or falsification of records will make the student liable for disciplinary action after being investigated by the Dean of Students. Proven violations of this nature will result in the student being dropped from the class with an "F".

Students living outside the 50 mile radius of Texarkana College, and do not wish to drive to the TC campus to take their tests, must find their own proctor.

An acceptable proctor must be one of the following:

- Educational administrator or librarian at a community college, university, or high school
- Librarian at a public library

- Learning Center, ESO, or an officer of higher rank than the student, if in the military
- College, university, or private testing center

Note: Any cost for either the proctor or proctoring site is the full responsibility of the student. (This applies only if you are not taking tests at TC)
