Attendance Policy

You may be dropped from the course without notice after a total of 3 class absences (3 times tardy counts as one absence). Only currently enrolled students are allowed to attend classes and labs. Any student who officially withdraws from the course before the drop date and before the instructor has dropped the student from the course will receive a grade of "W" unless instructor drops the student with an "F" for cheating. Students are expected to attend, regularly, all classes in the course for which they are enrolled.

Note: In this class, a student will be counted present for the week by following any one of these 3 methods:

- a. If the student attends a scheduled class session,
- b. If the student is caught up or ahead in their work, and the student notifies the instructor within 2 days before the scheduled class,
- c. Or if the student has completed all work for the course (Notify the instructor).

Failure to abide by the above 3 rules will result in the student being dropped from class with a W. Being caught up in their work means "having **taken the required tests** and having **turned in all assigned work by the required due dates**."

For any student that just stops coming to class and chooses to make an F or a W, the last date they attended will be listed on the final grade sheet and they will most likely have to pay back money received from grants or scholarships.

Summary

The class format is what is called "Hybrid." You can complete all lab work from home, but tests are to be taken in the Texarkana College Testing Center by the appropriate deadlines. You will be required to attend scheduled class sessions via Microsoft Teams, and complete adequate weekly work to be counted present on attendance. Class time will consist of covering new concepts from the chapters, plus concepts chosen by the instructor. As stated, you are required to attend scheduled class sessions. Over the semester, you are allowed two absences.

Adequate personal time will be needed for completion of labs and assigned projects. Because of the constant changing nature of the Web and web design material, you may be assigned additional reading material throughout the semester. Students will be assigned projects (Chapter Tutorials) from the book. These will be supplemented with the Lab Assignments at the end of each chapter and other assignments given by the instructor to provide repetitive learning of web design concepts. Your lab time will be devoted to the completion of assigned projects (tutorials & labs) from the book, projects assigned from other sources, and the student's personal Web pages.

This course is designed to acquaint the student with web design fundamentals using HTML5 and CSS3 (Hypertext Markup Language 5 and Cascading Style Sheets 3). Study encompasses a brief introduction to the development and structure of the Internet and Web, Web and web design concepts and terminology, and web design practical usage, primarily for business and educational purposes. The student will learn the basics of web publishing using HTML. This is an essential knowledge for web design in the workplace or for the learning and use of a variety of script languages such as JavaScript, VB script, PHP, or working with ASP. Special emphasis is given to the study of XHTML and CSS.

The course objective is for the student to gain a fundamentally sound working knowledge of web page design. HTML (XHTML), the primary markup language used for web publishing, will be used by the student to complete assignments. Additionally, the student will design and create a personal website and subsequent pages. The proper completion of all required reading, lab projects and homework, and chapter tests should provide a solid basic foundation in preparation for a business or educational environment.

Tests are taken from the book and handouts, if any. These tests will account for 50% of the student's total grade. Failure to take a test by the appropriate deadline without prior approval from the instructor will result in the grade of zero (0) for that test. **Do not miss an exam!**

The tutorial labs and additional lab work will account for 25% of the student's final grade. A student will receive credit for work that has been promptly and fully completed. It is the student's responsibility to assure that all work is properly completed in a timely manner.

One of the larger assigned projects allows the student to create a personal home page and additional web pages (personal website) using HTML. This should be fun! This project will account for 20% of your grade.

A participation grade will account for 5% of the student's final grade. Students must attend all of the required class meetings, complete assignments by their due date, contribute to class discussion of topics being reviewed and show a genuine desire to learn web publishing. Quality participation by students can provide a "Win – Win" learning environment for all students.

The student must have *completed* all assigned projects in a *timely and orderly* manner **and** have the required grade average to earn an A in the course.

Computer Requirement Policy:

- Support for Chrome or Microsoft Edge Note: Firefox, Safari, or other browsers may not work on all TC applications
- Able to run Microsoft Office which will be provided free to TC students
- Adobe Reader or another PDF viewer
- Antivirus software such as Windows Defender or another 3rd party anti-virus solution
- The Respondus Lockdown browser is used for taking tests; therefore, the system must be capable of running this software. Most newer systems that meet other specifications should work.

Students should regularly backup content to prevent loss of coursework due to hardware failure. Backup copies of documents and other coursework may be placed on OneDrive cloud storage. OneDrive is included free of charge for all TC students.
