Student Learning Outcomes for the Course

Upon successful completion of this course, students will:

1. Apply scientific reasoning to investigate questions and utilize scientific tools such as microscopes and laboratory equipment to collect and analyze data.

2. Use critical thinking and scientific problem-solving to make informed decisions in the laboratory.

3. Communicate effectively the results of scientific investigations.

4. Define modern evolutionary synthesis, natural selection, population genetics, micro and macroevolution, and speciation.

5. Describe phylogenetic relationships and classification schemes.

6. Identify the major phyla of life with an emphasis on plants and animals, including the basis for classification, structural and physiological adaptations, evolutionary history, and ecological significance.

7. Describe basic animal physiology and homeostasis as maintained by organ systems.

8. Compare different sexual and asexual life cycles noting their adaptive advantages.

9. Illustrate the relationship between major geologic change, extinctions, and evolutionary trends.

Student Assessment

Attendance Policy

Roll will be taken during each class. It is recommended that students contact the instructor if missing a class is necessary. <u>A student with four absences may be dropped from the class for lack of attendance</u>. If an enrolled student stops attending class and chooses to receive an F, the last date they attended will be listed on the final grade sheet and they will most likely have to pay back money received from grants or scholarships. If a student leaves and returns during class or leaves the class before the class is over, he/she **may** be considered absent. Three tardies constitute one absence.

Excused Absences: A student's absence due to school trips and/or school business will not be counted against a student's allowable number of absences. Military duty and absences for Holy Days (FBD LEGAL) are covered in a separate section of the catalog and the student handbook. These are the only excused absences that are considered by Texarkana College. Responsibility for work missed for any absence is placed on the student. Instructors are required to allow students to make up work missed if the absence is due to military duty or religious holy days when students follow the correct notification procedures. Instructors are not required to allow students to make up work for absences due to other reasons.

Make-up Policy

Make-up exams should not be required. One make-up exam for full credit will be given. If another make-up exam must be administered to the same student, it will be worth 75% of the actual score on the exam. Make-up exams may differ in format from the original test. All make-up exams will be recorded as a zero until they are made up. This policy will also apply for inclass quizzes. Assignments that have a specific due date will have points deducted if they are late. Make-up assignments must be arranged during office hours or taken in the testing center on campus.

There will be a zero tolerance policy for any behavior that is disruptive and prevents or deters classroom learning. This behavior includes, but is not limited to, any use of vulgar language or rude behavior towards the instructor or any other student in the class.
