Student Learning Outcomes for the Course

- 1. Demonstrate understanding and knowledge of properties of functions.
- 2. Recognize and apply algebraic and transcendental functions and solve related equations.
- 3. Apply graphing techniques to algebraic and transcendental functions.
- 4. Compute the values of trigonometric functions for key angles in all quadrants of the unit circle measured in both radians and degrees.
- 5. Prove trigonometric identities.
- 6. Solve right and oblique triangles.

Student Requirements for Completion of the Course and Due Dates

This course provides the opportunity for students to receive both high school and college credit at the same time. Students who enter this course must meet the enrollment criteria of Texarkana College and must pay their tuition to TC for three hours of college credit. Grades will be recorded both at Texas High School and at Texarkana College and will appear on each institution's transcript.

Student Assessment

You have the opportunity to earn points in the following 3 areas. Your six weeks and final grade will be determined by the corresponding percentages.

Daily Grades/Homework/Quizzes - 50%

• Each homework and its quiz will be combined as one daily grade worth 100 points (20 points for the homework and 80 points for the quiz)

Tests - 50%

- Minimum of six daily grades and two test grades each six weeks
- Semester averages based upon 6/7 (6-six weeks grades) and 1/7 (semester exam)
