# Student Learning Outcomes for the Course

CRIJ 2314 Criminal Investigation is a study of investigative theory; collection and preservation of evidence; sources of information; interview and interrogation; use of the forensic sciences; and case and trial preparation.

## Student Requirements for Completion of the Course and Due Dates

Instruction for this course will be accomplished through lecture, audio/video presentations, discussions and student participation. Students should read the text for the course prior to arrival in class, be attentive and take notes during lecture. Student participation is essential to the learning process, and students are expected to answer questions and engage in professional debate. See the listed class schedule for assignment and test due dates. Students are required to have Scantron sheets and #2 pencils for tests.

Students are required to submit a **hand-written** essay including an introduction, body and conclusion in response to the Films on Demand video "**Stolen Goods: Crime Inc. - The Underground Economy**". The video can be accessed from the link on the course home page. However, if you are unable to open the link it can be accessed from Films on Demand at <a href="http://digital.films.com">http://digital.films.com</a> using the USER ID: texarkana and PASSWORD: texas, and searching for the video title. The essay will be due on Monday of the following week in class.

Students are required to submit five (5) brief **hand-written** responses to a Contemporary Criminal Justice issue during this semester. The response must state the issue being reported and the response of the student to the subject. Sources to consider using are newsprint, magazines, professional journals, television and/or radio news programs and internet news sites. A copy of the article must be submitted with the written response or the article or news program must be cited. As a **bonus** students may submit up to six (6) more responses, however under no circumstances will more than one response be accepted per week.

# **Attendance Policy**

Success in this course depends on your regular attendance and participation in class. Attendance will be taken at the beginning of each class period and students will be dropped from the course due to excessive unexcused absences. A student may be dropped from this course after their fourth absence. Three tardies constitute one absence. Approval will only be given in the case of unavoidable emergencies and you may be required to provide written proof. Students will be responsible for completing a written report for all material covered in class during their absence to be turned in at the next scheduled

meeting of class. Failure to turn in the report will result in you being shown absent for that class.

A student absent due to school trips and/or school business will not have the absence counted against the student's allowable number of absences. A student absent for military duty or for recognized Holy Days will not have the absence counted against the student's allowable number of absences in accordance with the Texarkana College Student Handbook. ## **Class Conduct Policy**
