# **Student Learning Outcomes for the Course**

CRIJ 2328 Police Systems and Practices is a study of the Law Enforcement profession; organization of law enforcement systems; the police role; police discretion; ethics; police-community interaction; and current and future issues.

# Student Requirements for Completion of the Course and Due Dates

Instruction for this course will be accomplished through independent study to include: lecture, audio/video presentations, discussions and student participation. Assignments will be presented and completed through both web-based and campus assignments. Students should read the text for the course prior to answering discussion questions and taking exams. Student participation is essential to the learning process, and students are expected to answer questions and engage in professional debate. See the listed class schedule for assignment and test due dates. Students are required to have Scantron sheets and #2 pencils for tests and make arrangements to take the tests each week.

Students are required to submit a **hand-written** essay including an introduction, body and conclusion in response to the Films on Demand video "**Crime in the Cities: Public Safety at Risk**". The video can be accessed from the link on the course home page. However, if you are unable to open the link it can be accessed from Films on Demand at <u>http://digital.films.com</u> using the USER ID: texarkana and PASSWORD: texas, and searching for the video title. The essay will be due on Monday of the following week in class.

Students are required to submit five (5) brief responses to a Contemporary Criminal Justice issue during this semester. The response must state the issue being reported and the response of the student to the subject. Sources to consider using are newsprint, magazines, professional journals, television and/or radio news programs and internet news sites. A copy of the article must be submitted through attachment with the response or the article or news program must be cited. As a **bonus** students may submit up to six (6) more responses, however under no circumstances will more than one response be accepted per week.

## **Attendance Policy**
