Student Learning Outcomes for the Course

CRIJ 2328 Police Systems and Practices is a study of the Law Enforcement profession; organization of law enforcement systems; the police role; police discretion; ethics; police-community interaction; and current and future issues.

Student Requirements for Completion of the Course and Due Dates

Instruction for this course will be accomplished through lecture, audio/video presentations, discussions and student participation for the face-to-face portion of the course. Students will complete all assignments including exams through the web-based course homepage. Students should read the text for the course prior to arrival in class, be attentive and take notes during lecture. Notes will occasionally be allowed for exams. Student participation is essential to the learning process, and students are expected to answer questions and engage in professional debate both in the classroom and web-based posted forum questions. See the listed class schedule for assignment and test due dates.

(Exams are worth 75% of your final grade)

Students are required to submit an essay including an introduction, body and closing paragraphs in response to the Films on Demand video "**Inside Chicago's Gang War**". The essay must be a minimum of one full page in length. The video can be accessed from the link on the course home page. However, if you are unable to open the link it can be accessed from Films on Demand at http://digital.films.com using the USER ID: texarkana and PASSWORD: texas, and searching for the video

title. The essay will be due on Monday of the following week in class. Please refer to Syllabus for date of assignment.

(This assignment is worth 10% of your final grade)

Students are required to complete a **typed** Informative Essay about a substantial contemporary criminal justice issue that will be submitted as an assignment through the course homepage. The essay should be four to six double spaced pages long and consist of at least five or six paragraphs including an introduction, body and closing paragraphs. The essay must contain information from a minimum of three cited sources including but not limited to peer-reviewed articles, books and websites. Do not use Wikipedia as a source. The essay will be graded on content and a demonstration of investigative effort in developing and expressing the factual information on the issue. The topic for the assignment must be approved by Friday, February 12, 2016, before starting the essay. You will be allowed to turn the essay in once for a preliminary review and response before receiving a final grade, however the final copy must be submitted for grading no later than Friday, April 1, 2016.

(This assignment is worth 10% of your final grade)

Students are required to submit five (5) brief responses to a Contemporary Criminal Justice issue during this semester. The response must be a minimum of a full paragraph in length and state both the issue being reported and the response of the student to the subject. Sources to consider using are newsprint, magazines, professional journals, television and/or radio news programs and internet news sites. A copy of the article must be submitted with the written response or the article or news program must be cited. As a **bonus** students may submit up to six (6) more responses, however under no circumstances will more than one response be accepted per week.

(This assignment is worth 5% of your final grade)

Attendance Policy

Success in this course depends on your regular attendance and participation in class and through completion of assignments on the course homepage. Attendance will be taken at the beginning of each class period and students will be dropped from the course due to excessive unexcused absences. A student may be dropped from this course after their third absence. Three tardies constitute one absence.
