Student Learning Outcomes for the Course

CRIJ 2328 Police Systems and Practices is a study of the Law Enforcement profession; organization of law enforcement systems; the police role; police discretion; ethics; police-community interaction; and current and future issues.

Student Requirements for Completion of the Course and Due Dates

Instruction for this course will be accomplished through lecture, audio/video presentations, discussions and student participation for the face-to-face portion of the course. Students will complete all assignments including exams through the web-based course homepage. Students should read the text for the course prior to arrival in class, be attentive and take notes during lecture. Student participation is essential to the learning process, and students are expected to answer questions and engage in professional debate both in the classroom and web-based posted forum questions. See the listed class schedule for assignment and test due dates.

Students are required to submit an approximately one page essay including an introduction, body and closing paragraphs in response to the Films on Demand video "**Inside Chicago's Gang War**". The essay must be a minimum of one full page in length. The video can be accessed from the link on the course home page. However, if you are unable to open the link it can be accessed from Films on Demand at <http://digital.films.com> using the USER ID: texarkana and PASSWORD: texas, and searching for the video title. The essay will be due on Monday of the following week in class. Please refer to Syllabus for date of assignment.

Students are required to complete a **typed** Informative Essay about a substantial contemporary criminal justice issue that will be submitted as an assignment through the course homepage. The essay should be four to six double spaced pages long and consist of at least five or six paragraphs including an introduction, body and closing paragraphs. The essay must contain information from a minimum of three cited sources including but not limited to peer-reviewed articles, books and websites. At least one source must be a peer-reviewed article. Do not use Wikipedia as a source. The essay will be graded on content and a demonstration of investigative effort in developing and expressing the factual information on the issue. Do not merely write a paper about your opinion on a subject. The topic for the assignment must be approved by Friday, April 05, 2019, before starting the essay. You will be allowed to turn the essay in once for a preliminary review and response before receiving a final grade if it is turned in before the due date and you request I review it by email, however the final copy must be submitted for grading no later than Friday, April 19, 2019 at 11:55pm.

Students are required to submit five (5) brief responses to a Contemporary Criminal Justice issue during this semester through the course homepage. The response must be a minimum of a full paragraph in length and state both the issue being reported and the response of the student to the subject. Sources to consider using are newsprint, magazines, professional journals, television and/or radio news programs and internet news sites. A copy of the article must be submitted through attachment with the response or the article or news program must be cited. The five required responses must be completed in the first ten weeks of the semester so watch for due dates. As a **bonus** students may submit up to six (6) more responses, however under no circumstances will more than two (2) responses be accepted per week.

Attendance Policy

Success in this course depends on your regular participation in class through the course homepage. Attendance will be determined through weekly participation in discussion questions as assigned and weekly exams. A student will be dropped from the course due to excessive unexcused absences. A student may be dropped from this course after their second absence. In accordance with attendance requirements for online classes published in the Online Course Handbook for Students on the Texarkana College website, online students may be dropped for failing to complete weekly activities as assigned by the instructor. Approval will only be given in the case of unavoidable emergencies and you may be required to provide written proof.

Class Conduct Policy

The classroom should be treated as a professional environment and distractions should be kept to a minimum. Students should make arrangements with the instructor in advance if they need to leave class before dismissal or arrive late for class. Students that have made arrangements to leave class early should sit as close to the door as possible. There will be a zero tolerance policy for any behavior that is disruptive to classroom learning including web-based activity. The field of Criminal Justice often involves topics that some might find controversial including but not limited to political and religious beliefs. Topics discussed in class are for an educational purpose and students must remain civil and respectful. Students asked to leave the class for improper behavior will be dropped from the course.
