Each student within the group will be responsible for researching and learning about one of the following aspects in relation to the author and the author’s works: style, topics and themes, or influences.</p> <p>(2.) Each student will then discuss how the author’s works and social involvement influenced him/her, including any perspective adjustments as a reflection of new understanding. (3.) Next, the group will select a civic organization (ideally related to their author’s experiences) and spend at least two hours participating in that organization’s activities. The students will reflect on what this experience has taught them about themselves and their civic duty and on the ability of such organizations to solve specific problems.</p> <p>The students will then work collaboratively to construct a unified Power Point including the 3 aforementioned sections and a citation slide.
