**Student Learning Outcomes for the Course**

CRIJ 1301 Introduction to Criminal Justice will introduce the student to the history, philosophy, and development of the criminal justice system; crime and criminal justice definitions. The nature and impact of crime, overview of the criminal justice system, law enforcement, prosecution and defense, court system, trial process and corrections.

**Student Requirements for Completion of the Course and Due Dates**

Instruction for this course will be accomplished through Web-based content and activities on the course homepage, audio/video presentations and weekly discussions between students and I posted on the course homepage. Students should read the text for the course prior to making a post or response. Student participation is essential to the learning process, and students are expected to answer questions and engage in professional debate. This course will cover material involving politics and religion. It is important that you understand some topics might be controversial, but are discussed for an academic purpose. Be respectful and professional in your responses. See the listed class schedule for assignment and test due dates. Prior to beginning the course students will take the introductory quiz. It is the student's responsibility to ensure they are accessing the course web-based content from a secure location that will not lose connectivity.

Students will complete all exams through web-based content. All exams will be timed. If you feel you have inadequate time to complete the exam please contact me and arrangements will be made to complete the exam at the campus testing center. In the event of losing internet connectivity while completing an exam, you must complete and submit a LMS Interrupted Test form located in the blue column on the left side of your course homepage. This will notify the Texarkana College Information Technology department of the issue. In addition, you must immediately notify me of the incident. Repeated requests to reopen exams due to losing connectivity will result in a requirement to take exams in the campus testing center.

Students are required to submit an essay including an introduction, body and conclusion in response to the Films on Demand video “The Brain and Violence: Secrets of Your Mind” the first week of the Semester. The video can be accessed from the link on the course home page. However, if you are unable to open the link it can be accessed from Films on Demand at <http://digital.films.com> using the USER ID: texarkana and PASSWORD: texas, and searching for the video title. The essay should be approximately 500 words long and must be posted by Sunday at midnight.

Students are required to complete a **typed** Informative Essay about a substantial contemporary criminal justice issue that will be submitted as an assignment through the course homepage. The essay should be two to three double spaced pages long and consist of at least an introduction, body and closing paragraphs. The essay must contain information from a minimum of three cited sources including but not limited to peer-reviewed articles, books and websites. Do not use Wikipedia as a source. The essay will be graded on content and a demonstration of investigative effort in developing and expressing the information on the issue. Do not merely write a paper about your opinion on a subject. Additional guidance can be found on the course home page listed as Informative Research Essay with rubric. The topic for the assignment must be approved by Friday, June 14, 2019, before starting the essay. You will be allowed to turn the essay in once for a preliminary review and response before receiving a final grade if it is turned in at least a week before the due date and you request I review it by email, however the final copy must be submitted for grading no later than Friday, June 28, 2019 at 11:55pm.

Students are required to submit five (5) brief responses to a Contemporary Criminal Justice issue during this semester. The response must state the issue being reported and the response of the student to the subject. Sources to consider using are newsprint, magazines, professional journals, television and/or radio news programs and internet news sites. A copy of the article must be submitted through attachment with the response or the article or news program must be cited. As a **bonus** students may submit up to six (6) more responses, however under no circumstances will more than three (3) response be accepted per week.
