# Student Learning Outcomes for the Course

CRIJ 2314 Criminal Investigation is a study of investigative theory; collection and preservation of evidence; sources of information; interview and interrogation; use of the forensic sciences; and case and trial preparation.

#### Student Requirements for Completion of the Course and Due Dates

Instruction for this course will be accomplished through lecture, audio/video presentations, discussions and student participation for the face-to-face portion of the course. Students will complete all assignments including exams through the web-based course homepage. Students should read the text for the course prior to arrival in class, be attentive and take notes during lecture. Student participation is essential to the learning process, and students are expected to answer questions and engage in professional debate both in the classroom and web-based posted forum questions. See the listed class schedule for assignment and test due dates.

Students will complete all exams through web-based content. All exams will be timed. If you feel you have inadequate time to complete the exam please contact me and arrangements will be made to complete the exam at the campus testing center. In the event of losing internet connectivity while completing an exam, you must complete and submit a LMS Interrupted Test form located in the blue column on the left side of your course homepage. This will notify the Texarkana College Information Technology department of the issue. In addition, you must immediately notify me of the incident. Repeated requests to reopen exams due to losing connectivity will result in a requirement to take exams in the campus testing center.

Students will complete all exams through web-based content. All exams will be timed. If you feel you have inadequate time to complete the exam please contact me and arrangements will be made to complete the exam. In the event of losing internet connectivity while completing an exam, you must complete and submit a LMS Interrupted Test form located in the blue column on the left side of your course homepage. This will notify the Texarkana College Information Technology department of the issue. In addition, you must immediately notify me of the incident. Repeated requests to reopen exams due to losing connectivity will result in a requirement to take exams on the campus. Following Thanksgiving break, all classes at the college will be taught through virtual and/or online course delivery (including final exams) for the remainder of the fall semester, November 30-Decmber 14. No face to face classes will be held on campus during this time.

Students are required to submit an essay that will be submitted as an assignment through the course homepage; including an introduction, body and closing paragraphs in response to the Films on Demand video "Eyewitness: What Actually Happened". The video can be accessed from the link on the course home page. However, if you are unable to open the link it can be accessed from Films on Demand at <a href="http://digital.films.com">http://digital.films.com</a> using the USER ID: texarkana and PASSWORD: texas, and searching for the video title. The essay will be due on Sunday at midnight of the week it is assigned. Please refer to Syllabus for date of assignment.

Students are required to complete a **typed** Informative Essay about a substantial contemporary criminal justice issue that will be submitted as an assignment through the course homepage. The essay must be a minimum of four complete to six double spaced pages long and consist of at least five or six paragraphs including an introduction, body and closing paragraphs, with works cited page attached. The essay must contain information from a minimum of three cited sources including but not limited to peer-reviewed articles, books and websites. At least one source must be a peer-reviewed article. Do not use Wikipedia as a source. The essay will be graded on content and a demonstration of investigative effort in developing and expressing the factual information on the issue. Do not merely write a paper about your opinion on a subject. The topic for the assignment must be approved by Friday, October 23, 2020, through email and failure to obtain approval will result in a ten (10)-point reduction in grade for the assignment. The assignment must be submitted through the course homepage for grading no later than Friday, November 20, 2020. There will be no exceptions made for late submissions.

Students are required to submit five (5) brief responses to a Contemporary Criminal Justice issue during this semester through the course homepage. The response must be a minimum of a full paragraph in length and state both the issue being reported and the response of the student to the subject. Sources to consider using are newsprint, magazines, professional journals, television and/or radio news programs and internet news sites. A copy of the article must be submitted through attachment with the response or the article or news program must be cited. The five required responses must be completed in the first ten weeks of the semester so watch for due

dates. As a **bonus** students may submit up to six (6) more responses, however under no circumstances will more than two responses be accepted per week.

## **Attendance Policy**

Success in this course depends on your regular attendance and participation in class and through completion of assignments on the course homepage. Attendance will be taken at the beginning of each class period and students will be dropped from the course due to excessive unexcused absences. A student may be dropped from this course after their second absence. Two tardies constitute one absence. Approval will only be given in the case of unavoidable emergencies and you may be required to provide written proof.

A student absent due to school trips and/or school business will not have the absence counted against the student's allowable number of absences. ## **Class Conduct Policy**

Cellular telephones and beepers must have the ringer turned off and not be visible in the class unless an emergency situation exists. This situation must be discussed with the instructor prior to class. If a student is caught text-messaging in class, the student may be dropped from the class. If a student's cell phone rings in class, the student will receive a warning and may be dropped from class after the second offense. Use of laptops or tablets is not allowed in class as it is a distraction to those around you.

The classroom should be treated as a professional environment and distractions should be kept to a minimum. Students should make arrangements with the instructor in advance if they need to leave class before dismissal or arrive late for class. Students that have made arrangements to leave class early should sit as close to the door as possible. There will be a zero tolerance policy for any behavior that is disruptive to classroom learning. Professional debate is encouraged to enhance the learning environment however rude and vulgar behavior will not be tolerated. This includes ANY use of vulgar language or rude behavior toward instructor or any other student in the class. The field of Criminal Justice often involves topics that some might find controversial including but not limited to political and religious

beliefs, and these topics will be discussed. Topics discussed in class are for an educational purpose and students must remain civil and respectful. Students asked to leave the class for improper behavior will be dropped from the course.
