- 1. Construct and identify major scale and all forms of the minor scale.
- 2. Construct and identify triads and seventh chords in all inversions.
- 3. Analyze triads in harmonic context utilizing standard roman-numeral symbols.
- 4. Compose music in standard four-part chorale style.
- 5. Identify small musical forms.
- 6. Demonstrate musical concepts covered in class, including scales, triads, and basic harmonic progression on the keyboard.
- 7. Demonstrate an understanding of rhythmic meter and note duration through score analysis and composition.

Student Requirements for Completion of the Course and Due Dates

- 1. Students will complete a thorough study of the text, class notes, and recordings
- 2. Students will take unit tests at the end of every chapter
- 3. Students will complete homework assignments
- 4. Students will be required to watch four Classical music events on YouTube during the semester

Student Assessment

Final grade will be a combination of all test grades and final (50%), homework grades (30%), attending four concerts (10%), and active participation in class discussion and activities (10%).

Class Schedule

Students will cover a unit every 2-3 weeks and will be tested at the end of the unit. - The Respondus Lockdown browser is used for taking tests; therefore, the system must be capable of running this software. Most newer systems that meet other specifications should work.

COVID -19 Protocols for Exposure

I was around someone who tested positive to COVID-19. Now what?

Some very important questions need to be asked if you were around someone who tested positive for COVID-19...

- Were you within 6 feet of someone who has COVID-19 for at least 15 minutes?
- Have you provided care at home to someone who is sick with COVID-19?
- Did you have direct physical contact with the person (touched, hugged, etc.)?
- · Did you share eating or drinking utensils?
- Did they sneeze, cough, or somehow get respiratory droplets on you?
- · Are you feeling symptomatic?

If you answered YES to any or all the questions above, it is recommended that you...

- Stay home for 14 days after your last contact with a person who has COVID-19
- Watch for fever (100.4 °F), cough, shortness of breath, or other symptoms of COVID-19
- If possible, stay away from others, especially people who are at higher risk for getting very sick from COVID-19

Remember, the wearing of face masks, frequent hand sanitization, and social distancing has proven to significantly decrease the likelihood of transferring COVID-19.



Special note for Healthcare Workers and Emergency Responders


