Textbook Information: Tonal Harmony – with an Introduction to Twentieth-Century Music, Stefan Kostka & Dorothy Payne. Sixth Edition, McGraw Hill. ISBN#978-007-340135-5.

Course Description: The study of analysis and writing of tonal melody and diatonic harmony, including all diatonic chords and seventh chords in root position and inversions, non-chord tones, and functional harmony. Introduction to more complex topics, such as modulation, may occur. Optional correlated study at the keyboard.

Student Learning Outcomes for the Course

- 1. Construct and identify all triads and seventh chords in root position and inversions.
- 2. Properly utilize and identify all non-chord tones.
- 3. Analyze harmonic progressions utilizing standard roman-numeral symbols.
- 4. Compose original harmonic progressions that properly utilize functional harmony.
- 5. Demonstrate on the keyboard musical concepts covered in class, including triads in inversions and progressions with non-chord tones.

6. Demonstrate an understanding of rhythmic meter and note duration through score analysis and composition.

Student Requirements for Completion of the Course and Due Dates

- 1. Students will complete a thorough study of the text & class notes
- 2. Students will take unit tests at the end of every chapter
- 3. Students will complete homework assignments on time
- 4. Students will be required to attend five Classical music events during thesemester

Student Assessment

Final grade will be a combination of all test grades and final (55%), timely return of homework papers (20%), attending five concerts (10%), and active participation in class discussion and activities, as well as punctuality consistent attendance (15%)

- Antivirus software such as Windows Defender or another 3rd party anti-virus solution
- The Respondus Lockdown browser is used for taking tests; therefore, the system must be capable of running this software. Most newer systems that meet other specifications should work.

Students should regularly backup content to prevent loss of coursework due to hardware failure. Backup copies of documents and other coursework may be placed on OneDrive cloud storage. OneDrive is included free of charge for all TC students.

I was around someone who tested positive to COVID-19. Now what?

Some very important questions need to be asked if you were around someone who tested positive for COVID-19...

- Were you within 6 feet of someone who has COVID-19 for at least 15 minutes?
- Have you provided care at home to someone who is sick with COVID-19?
- Did you have direct physical contact with the person (touched, hugged, etc.)?
- Did you share eating or drinking utensils?
- Did they sneeze, cough, or somehow get respiratory droplets on you?
- Are you feeling symptomatic?

If you answered YES to any or all the questions above, it is recommended that you...

- Stay home for 14 days after your last contact with a person who has COVID-19
- Watch for fever (100.4 F), cough, shortness of breath, or other symptoms of COVID-19
- If possible, stay away from others, especially people who are at higher risk for getting very sick from COVID-19

Remember, the wearing of face masks, frequent hand sanitization, and social distancing has proven to significantly decrease the likelihood of transferring COVID-19.



Special note for Healthcare Workers and Emergency Responders


