Student Learning Outcomes For The Course

Upon successful completion of this course, students will:

1. Compute the values of trigonometric function for key angles in all quadrants of the unit circle measured in both degrees and radians.
2. Graph trigonometric functions and their transformations.
3. Prove trigonometric identities.
4. Solve trigonometric equations.
5. Solve right and oblique triangles.
6. Use the concepts of trigonometry to solve applications.

Student Requirements For Completion Of The Course And Due Dates

1. Homework assignments are to be completed using MyMathLab (MML). You will receive credit for assignments turned in on or before the due date. Due dates are listed on MyMathLab and in the Tentative Course Schedule. Any changes in due date will be posted on MyMathLab. At the end of the semester your lowest 3 homework grades will be dropped and will not count towards your homework average.
2. Tests – All tests will be administered online through MML and proctored at your school district. There will be a total of 6 chapter tests as follows:

Test 1: Chapter 1	Test 2: Chapters 2 & 7.1-7.3	Test 3: Chapter 3
Test 4: Chapter 4	Test 5: Chapter 5	Test 6: Chapter 6

3. Final Exam – There will be a multiple choice comprehensive final exam that will be administered online using MML and proctored at your school district according to the campus-wide final exam schedule. Practice final exams are available for purchase in the bookstore. The final exam may be used to replace your lowest chapter test score if your final exam score is higher.

Student Assessment

You have opportunity to earn points in the following 3 areas. Your final grade will be determined by the corresponding percentages.

Homework	20%
Chapter Tests	60%
Final Exam	20%

Final Grade = $0.20 \times \text{homework average} + 0.60 \times \text{chapter test/core curriculum average} + 0.20 \times \text{final exam}$

Absentee Policy

Texarkana College's absentee policy allows instructors to withdraw a student from a course due to excessive absences. If a student leaves and returns during class or leaves the class before the class is over, he/she **may** be considered absent. Three tardies may be counted as one absence. Experience demonstrates that regular attendance enhances academic success. As such, students are expected to attend each meeting of their registered courses.

A student should not stop attending a class without formally withdrawing from the course by the institutions published Last Day for Students to Drop. If a student stops attending class after the published Last Day for Students to Drop, the student may receive a grade of "F" in the class. The instructor will submit the last date of attendance for students receiving a grade of "F" or "W".

Withdrawal from a course(s) may affect a student's current or future financial aid eligibility. Students should consult the Financial Aid Office to learn both short and long term consequences of a withdrawal.

Excused Absences

An absence is defined as any time you are not in class. A student's absence due to school trips and/or school business will not be counted against a student's allowable number of absences. Military duty and absences for Holy Days (FBD LEGAL) are covered in a separate section of the catalog and the student handbook. These are the only excused absences that are considered by Texarkana College. Responsibility for work missed for any absence is placed on the student. Instructors are required to allow students to make up work missed if the absence is due to military duty* or religious holy days when students follow the correct notification procedures. Instructors are not required to allow students to make up work for absences due to other reasons.

Maximum Allowable Absences

The maximum allowable absences refers to the maximum number of unexcused absences a student is allowed before a student may be dropped from the course. After official registration for a three credit hour academic class that meets two days a week, the instructor may withdraw a student from the course if they exceed 4 absences. This means you may be dropped from the course for having 5 recorded absences.

Make-Up Policy

Students may make up missed tests if the absence is due to military duty or religious holy days when students notify the instructor prior to being absent. Students may also make up tests due to an emergency (documentation may be required). In the event of an emergency, the student must contact the instructor prior to the test. Faculty members are not obligated to provide opportunities for students to make-up missed assignments and tests as a result of a student's absence from class. It is the student's responsibility to communicate with the instructor regarding absences and missed course work. The instructor has the final say whether or not a student will be allowed to make up the missed test. Make up tests may be a different form of the test. Any missed test will be recorded as a zero. Students may have the homework due date extended for excused absences (See excused absences above). You will not receive credit for homework assignments after the due date has passed. At the end of the semester your lowest 3 homework grades will be dropped and will not count towards your homework average.

Tutoring and Extra Help

Texarkana College also offers free tutoring to all students, including online students, in the Math Lab located on the second floor of the Library. In order to use the tutoring available in the Math Lab, simply bring your Student ID with you to the library, go upstairs to the area labeled Math Lab and use your ID to sign in (on the designated sign-in computer), then work on any math work at the computers or tables in the Math Lab area. Check with the Math Lab for current hours of operation.

Class Behavior

Each student must respect the learning environment of others, therefore, there will be a zero tolerance policy for any behavior that is disruptive to classroom learning. This includes ANY use of vulgar language or rude behavior toward instructor or any other student in the class. This also includes disruptive cell phone usage during class! Please be considerate of others who are trying to learn by using your cell phone appropriately during class time.

Course Correspondence:

Course correspondence will be through TC student email, REMIND, MyMathLab, or the email you provide when you sign up for MyMathLab. Grades and attendance will be posted on MyTC. It is the student's responsibility to check his/ her email, MyTC, and MyMathLab regularly for any information relating to the course.

Alternate Operations during Campus Closure

In the event of an emergency or announced campus closure due to a natural disaster or pandemic, Texarkana College may need to move to altered operations and course delivery methods. During this time, Texarkana College may opt to continue delivery of instruction through methods that include, but are not limited to: online learning management system (Jenzabar or Moodle), online conferencing through TEAMS, email messaging, and/or an alternate schedule. It is the responsibility of the student to monitor Texarkana College's website (www.texarkanacollege.edu) for instructions about continuing courses remotely, instructor email notifications on the method of delivery and course-specific communication, and Texarkana College email notifications for important general information.

COVID-19 Online/Virtual Environment Instructional Commitment

The ongoing Covid-19 situation will require that some course materials and instruction are provided through an online and/or virtual format. Even if all or a portion of a class was originally scheduled to meet face to face, social distancing guidelines associated with Covid-19 will limit the number of students who are able to attend face to face classes in person simultaneously. Further, circumstances associated with Covid-19 could cause the college to be forced to shift completely to an online and/or virtual delivery at any time during the semester. While TC faculty members are committed to providing students the option of face to face instruction if possible, students should be prepared to continue their classes in an online and/or virtual environment if necessary. Texarkana College is committed to maintaining engaging, high quality instruction regardless of the delivery format.

Computer Requirement Policy

Students are required to have a computer with Internet access for classes. The computer must be an actual computer – smart phones, iPads, Androids, Chromebooks, etc., are not acceptable substitutes because they lack software compatibility necessary to complete all assignments and tests. Financial costs for the necessary equipment and internet access are the responsibility of the student.

Students needing to purchase a computer may do so through the Texarkana College Bookstore. Systems purchased through the bookstore meet or exceed all requirements, are competitively priced, and may be purchased using financial aid funds. If the system is purchased through another source, it is the student's responsibility to ensure the system meets all requirements.

Computer systems requirements:

- Webcam, microphone, and speakers or headphones
- Windows 10 or a recent version of Mac OS (minimum Sierra). Windows 10 S mode is not supported
- Hardware capable of running Microsoft Teams (free download) and supports multi-media playback
- Support for Chrome or Microsoft Edge – Note: Firefox, Safari, or other browsers may not work on all TC applications
- Able to run Microsoft Office which will be provided free to TC students
- Adobe Reader or another PDF viewer
- Antivirus software such as Windows Defender or another 3rd party anti-virus solution
- The Respondus Lockdown browser is used for taking tests; therefore, the system must be capable of running this software. Most newer systems that meet other specifications should work.

Students should regularly backup content to prevent loss of coursework due to hardware failure. Backup copies of documents and other coursework may be placed on OneDrive cloud storage. OneDrive is included free of charge for all TC students.
