Catalog Description: A practical application of management procedures for early care and education programs, including a study of operating, supervising and evaluating programs.

Objectives: Students will exhibit an understanding of the leader's role, how to implement policies and procedures and effective communication with staff and parents.

Course Delivery: The class is a web-based, synchronous class. This means the class will meet virtually through Microsoft Teams according to the class schedule. This is like a face-to-face course except that students will attend virtually. Students are expected to turn their cameras on and participate in active learning. Portions of course delivery and content will also be through Moodle or Jenzabar.

Attendance, Absences and Tardies: You are expected to be online every Wednesday night. Participation is a large part of this class. You are allowed $\mathbf{2}$ absences. This is the maximum allowable before a student is dropped from class. Texarkana College's absentee policy allows instructors to withdraw a student from a course due to excessive absences. If a student leaves and returns during class or leaves the class before the class is over, you will be considered absent. I will take attendance at $6: 15$. You must be logged in with your camera on. Three tardies are equal to one absence.

Drop or Withdrawal: A student should not stop attending a class without formally withdrawing from the course. If a student stops attending class after the published last day for students to drop, the student may receive a grade of " F " in the class. The instructor will submit the last date of attendance for students receiving a grade of "F" or "W". Withdrawal from a course(s) may affect a student's current or future financial aid eligibility. Students should consult the Financial Aid Office to learn both short and long term consequences of a withdrawal.

Class attendance and Participation: Class participation is a must! We will do a lot of discussion questions and role play activities. Your input and listening to others will contribute to your learning. Some of the test questions will come from class discussions. Plan to attend class!

Homework: Homework assignments correspond with the chapter discussions. Homework will be submitted through Teams. Homework due dates are listed on the syllabus. Homework will vary from short answer questions to business reports. Be ready to discuss your homework each class.

## Observational Requirements

10 hours of online observation
