**Course Description-** This course is a sixteen-week course for **Non- STEM** students. This course is non-transferable and does not count toward a degree at Texarkana College. Prerequisite: Satisfactory placement scores. (TSIA2 Scores: 910-949 and ABE, level 3 or TSI Score: 320). Co-requisite: PYSC/EDUC 1300.

### **Textbook and Supplies**

- MyMathLab w/eText for Blitzer's Pathways to College Mathematics 2e-18 week access code (may be purchased in the TC bookstore or online through the Pearson website)
- Recommended 2 inch 3-ring binder for this class only

- Basic computer skills to access online resources and information

## **Student Learning Outcomes for the Course**

- 1. Students will perform conversions among decimals, fractions, and percents and interpret information from circle and line graphs involving percents.
- 2. Students will perform operations with decimals and fractions.
- 3. Students will understand sets, basic Venn Diagrams, and basic set operations.
- 4. Students will evaluate algebraic expressions and use linear equations in one variable to solve problems.
- 5. Students will calculate simple and compound interest problems.
- 6. Students will use proportional reasoning to solve problems using ratios, rates and proportions.
- 7. Students will determine perimeter, area, and volume and use dimensional analysis to change units of measurement.
- 8. Students will be introduced to the fundamentals of probability, sampling, frequency distributions, graphs and measures of central tendency.

## **Evaluation Method**

The grade for this course will be based on:

- 1. <u>Homework</u> Homework assignments will be completed online through MyMathLab. The best browsers to use are **Chrome and Firefox**.
  - a. Students must log in often and with a timely process to access and complete homework assignments. First day homework, register for MyMathLab (MML). You will have unlimited attempts per question. No late work accepted on assignments. Sign in to MyMathLab (MML) or refer to the schedule for assignment due dates.
  - b. Notebook Work completed inside and outside of class should be kept in yourbinder.
- 2. Participation/Discussion Students are expected to participate in class by being prepared for class, engaging in group activities, joining class discussions, and explaining their work to others. If you miss class, it is your responsibility to complete any assignments due.

#### 3. Exams - Students MUST take the exam during the time period given by the instructor.

There will be a total of 5 unit exams:

- Exam 1: Sections P.1 P.7 Exam 2: Sections 1.1 – 1,5, 1.7 Exam 3: Sections 2.1 – 2.4 Exam 4: Sections 5.1 – 5.3, 6.3, 6.4 Exam 5: Sections 7.4, 8.1 – 8.3 Exam 6: Lab grade
- 4. <u>Final Exam</u> The final will be a comprehensive exam. A comprehensive final exam is mandatory for all students.

#### Student Requirements for Completion of the Course and Due Dates

Homework assignments are to be completed using MyMathLab (MML). In order to earn credit, homework assignments should be completed by 11:59 p.m. on the next class day (see class assignment schedule). You will not receive any credit for assignments completed after the due date. **You**, the student, **are** responsible for all assignments regardless of whether you are present at the time of assignment. **Any missed assignment will be recorded as a zero.** At the end of the semester your **3 lowest homework grades** will be dropped and will not count towards your homework average. Even though the homework is online, you should still work your problems on paper.

#### **Student Assessment**

You have opportunity to earn points in the following 3 areas. Your final grade will be determined by the corresponding percentages.

- (1) Homework 20% (3 lowest scores dropped)
- (2) Major Tests 50%
- (3) Final Exam 30%

Final Grade = 0.2 x homework average + 0.5 x chapter test average + 0.3 x final exam

#### **Grading Scale**

**NOTE:** There is NO provision for earning extra credit in this course. You **MUST** receive a grade of A, B, or C in order to proceed to the next college level math class (MATH 1332 is the recommended college level math course).

#### **Computer Requirement Policy**

Students are required to have a computer with Internet access for classes. The computer must be an actual computer – smart phones, iPads, Androids, Chromebooks, etc., are not acceptable substitutes because they lack software compatibility necessary to complete all assignments and tests. Financial costs for the necessary equipment and internet access are the responsibility of the student.

Students needing to purchase a computer may do so through the Texarkana College Bookstore. Systems purchased through the bookstore meet or exceed all requirements, are competitively priced, and may be purchased using financial aid funds. If the system is purchased through another source, it is the student's responsibility to ensure the system meets all requirements.

Computer systems requirements:

- Webcam, microphone, and speakers or headphones
- Windows 10 or a recent version of Mac OS (minimum Sierra). Windows 10 S mode is not supported
- Hardware capable of running Microsoft Teams (free download) and supports multi-media playback
- Support for Chrome or Microsoft Edge Note: Firefox, Safari, or other browsers may not work on all TC applications
- Able to run Microsoft Office which will be provided free to TC students
- Adobe Reader or another PDF viewer
- Antivirus software such as Windows Defender or another 3<sup>rd</sup> party anti-virus solution
- The Respondus Lockdown browser may be used for taking tests; therefore, the system must be capable of running this software. Most newer systems that meet other specifications should work.

Students should regularly backup content to prevent loss of coursework due to hardware failure. Backup copies of documents and other coursework may be placed on OneDrive cloud storage. OneDrive is included free of charge for all TC students. ### Absentee Policy (https://www.texarkanacollege.edu/courses/)

Texarkana College's absentee policy allows instructors to withdraw a student from a course due to excessive absences. If a student leaves and returns during class or leaves the class before the class is over, he/she **may** be considered absent or tardy. **Three tardies constitute one absence.** 

Faculty members **are not** obligated to provide opportunities for students to make-up missed assignments and tests as a result of a student's absence from class. Regular attendance enhances academic success. As such, students are expected to attend class.

A student should not stop attending a class without formally withdrawing from the course by the institutions published Last Day for Students to Drop. If a student stops attending class after the published Last Day for Students to Drop, the student **may** receive a grade of "F" in the class. The instructor will submit the last date of attendance for students receiving a grade of "F" or "W".

Withdrawal from a course(s) **may** affect a student's current or future financial aid eligibility. Students should consult the Financial Aid Office to learn both short and long term consequences of a withdrawal.

### **Maximum Allowable Absences**

The maximum allowable absences refers to the maximum number of unexcused absences a student is allowed before a student may be dropped from the course. After official registration for a three hour academic class, the instructor may withdraw a student from the course if they exceed 4 absences. This means you may be dropped from the course for having **5 recorded absences**.

## **Excused Absences**

A student's absence due to school trips and/or school business will not be counted against a student's allowable number of absences. Military duty and absences for Holy Days (FBD LEGAL) are covered in a separate section of the catalog and the student handbook. These are the only excused absences that are considered by Texarkana College. Responsibility for work missed for any absence is placed on the student. Instructors are required to allow students to make up work missed if the absence is due to military duty or religious holy days when students follow the correct notification procedures. Instructors are not required to allow students due to other reasons.

### **Make-up Policy**

Any missed test will be recorded as a zero. Any student missing 2 major tests will be dropped from the course. If your final exam grade is higher than one of your unit test grades, the final exam grade will replace the lower test score. Your lab grade can not be replaced by your final exam. This means if you do miss a unit test, the 0 will be replaced with the score from your final exam. Students may have the homework due date extended for excused absences (See excused absences above). You will not receive credit for homework assignments after the due date has passed. At the end of the semester your **3** lowest homework grades will be dropped and will not count towards your homework average.

## **Class Behavior**

There will be a zero tolerance policy for any behavior that is a disruption to classroom learning. This includes ANY use of vulgar language or rude behavior toward instructor or any other student in the class. This also includes disruptive cell phone usage during our virtual class time! Please be considerate of others who are trying to learn.

## A student may be dropped from the course for any of the following reasons:

- 1. Missing 5 classes
- 2. Missing 2 major tests
- 3. Missing 5 weeks of lab time in the Math Lab
- 4. Any breach of classroom conduct (see student handbook)
- \*Being dropped from the course could affect your financial aid.

### **Required Lab Time**

Beginning the first full week of class, a student is required to complete a minimum of one hour (60 minutes) of lab time per calendar week (counted Monday through Friday). Your hour does not have to be completed in one session. You may put in a minimum of fifteen minutes at any time during the week. Any session shorter than 15 minutes will not be counted. You may be dropped from this course(s) if you fail to complete five weeks of lab time.

You accumulate time by going to the Math Lab located on the second floor of the library .

<u>Math Lab</u>: The Math Lab is a great place to complete homework. There are computers available as well as free Math tutors. In order for your Math Lab time to be counted you must sign in each time you enter the Lab and sign out each time you leave the lab. If you fail to sign out your time will be deleted. The Math Lab will provide me with a copy of the sign in sheet each week, you do not have to bring anything to me for your time to be counted. Hours of operation will be posted in the Math Lab and on the Texarkana College webpage.

### Lab Grade

- Each student will begin the semester with a lab grade of **100**. Each week that you do not complete your assigned lab 10 points will be deducted from your lab grade.
- This lab grade will count as a test grade.
- I will not calculate your final lab grade until the final test is taken for each course. If you want to know your lab grade during the semester, you will need to keep up with your own lab time.

### **Course Correspondence**

Any course correspondence will be through TC student email. It is the student's responsibility to check his/ her TC email regularly for any communication related to the course.

#### **Academic Integrity Statement**

Scholastic dishonesty, involving but not limited to cheating on a test, plagiarism, collusion, or falsification of records will make the student liable for disciplinary action after being investigated by the Dean of Students.
